# ENVIRO-GRIP<sup>™</sup> PRIMER WBs

A Three Component, Low VOC, Waterborne Epoxy Primer for Concrete, Wood, Modified Bitumen, and Asphalt

#### **1.01 DESCRIPTION**

Enviro-Grip<sup>™</sup> Primer WBs is a three component (resin, hardener, and water), fast drying, waterborne, epoxy primer with low VOC and low odor. For use on concrete, wood, modified bitumen, and asphalt. Please use the correct product grade that complies with VOC regulations as per federal, state, county and city regulations/codes at the place of installation of product.

#### **1.04 COLOR**

Side-A: white, Side-B: black

#### **1.05 PACKAGING**

3.5-gallon kit: 1 gallon (3.78 liters) can of Side-A white liquid and 1 1/4 gallons (4.73 liters) can of Side-B black liquid. Add 1 1/4 gallons (4.73 liters) of water while mixing at site.

#### **1.06 SURFACE PREPARATION**

Refer to General and Safety Guidelines for complete information. Concrete surfaces require a medium sandpaper finish equal to or greater than an ICRI CSP #3. Surface preparation may be completed by shotblasting or the use of Poly-Tuff Profile and Etch cleaner. Peel and adhesion tests are recommended. Install a 100-200 sqft (9.30-18.58 sqm) mock up of the system to be installed and approve for aesthetics, color, texture, actual coverage rates and functionality before proceeding.

#### 1.07 MIXING

It is important to remember that Enviro-Grip<sup>™</sup> Primer WBs has a limited pot life of about 45-60 minutes. Pre-mix Side-A and Side-B components for up to 2 minutes.

Add 1 gallon (3.78 liters) of Side-A resin to 1.25 gallons (4.73 liters) of Side-B hardener. Mix thoroughly with a Jiffy Blade for 3 minutes. Mix until the color becomes uniform.

Slowly add 1.25 gallons (4.73 liters) of potable water to the mixture while under agitation. Mix for an additional 2 minutes until the contents are fully dispersed. The fully mixed material will appear as a off-white or cream color. Any mixed product not used in one hour should be properly disposed, even if the product appears usable.

#### APPLICATION 2.01 APPLICATION BASICS

Enviro-Grip™ Primer WBs should be applied by first pouring a bead of material on the surface to be coated. Spread the material using a flat squeegee. Enviro-Grip™ Primer WBs is a low viscosity product, allow to flow out in front of the squeegee.

Allow for sufficient wetting of the surface and ensure that the recommended coverage rate of 1 gallon per 300-450 sqft or 300-450 sqft/gallon (0.08-0.14 liters/sqm) is achieved. Backroll the covered area, utilizing a 1/4" (0.64 cm) nap roller, to eliminate puddles on the surface.

Minimize the overlap from batch to batch applications while achieving complete coverage. Coverage rates and cure times will vary depending on temperature, relative humidity, surface roughness and porosity, aggregate selection and embedment, and application technique. Coverage rates provided are optimal and are not guaranteed.

Enviro-Grip™ Primer WBs has a maximum recoat window of 8 to 24

hours. If the maximum recoat window is missed, regrind the surface with 80 grit, followed by a thorough sweeping and vacuuming of the area.

The following information is meant to be used as a general guideline only. Consult the project specification and your Poly-Tuff Systems International (PSI) representative for specific installation procedures.

1. IMPORTANT: Enviro-Grip<sup>™</sup> Primer WBs must be protected from freezing. If Enviro-Grip<sup>™</sup> Primer WBs is frozen, DO NOT USE.

2. Minimum/Maximum substrate temperature:  $60^{\circ}F-95^{\circ}F$  (15.5°C-35°C).

3. Minimum/Maximum relative humidity: 10%-85%.

4. Substrate temperature must be  $5^\circ\text{F}$  (3°C) above measured dew point.

5. Conduct quantitative anhydrous calcium chloride testing in accordance with ASTM-F1869. Maximum acceptable test result is 8 pounds per 1,000 sq/ft per 24 hours.

6. Freshly applied Enviro-Grip<sup>™</sup> Primer WBs should be protected from dampness, condensation, and water for at least 24 hours.

7. Do not add any type of thinner to Enviro-Grip<sup>™</sup> Primer WBs. Addition of thinners will slow the cure and reduce the ultimate properties of Enviro-Grip<sup>™</sup> Primer WBs.

8. Enviro-Grip<sup>™</sup> Primer WBs will discolor over time when exposed to sunlight (UV) and under certain artificial lighting conditions. It should be coated with a UV resistant, light stable topcoat within 48 hours of application.

9. Pinholed concrete surfaces may require Enviro-Grip<sup>™</sup> #1 or 404FC primer. Contact a PSI Representative for project specific recommendations.

#### **2.02 EQUIPMENT CLEANUP**

Equipment should be cleaned with an environmentally-safe solvent, as permitted under local regulations, immediately after use.

#### 2.03 SHELF LIFE AND STORAGE

Enviro-Grip<sup>™</sup> WBs has a shelf life of 12 months from date of manufacture in original, factory-sealed containers when stored indoors at a temperature between 60-95°F (15-35°C).

#### 2.04 CAUTION

Enviro-Grip<sup>™</sup> WBs Side-A Resin contains - IRRITANT, SENSITIZER. Contains epoxy resins. Eye irritant. May cause skin/respiratory irritation.
